Executive Summary

The Audubon Center of the North Woods (ACNW) is a non-profit organization located in Sandstone whose mission is to instill a connection and commitment to the environment in all communities through experiential learning. ACNW has a Charter School Division (CSD) located in Minneapolis that carries out activities related to charter school authorizing with some support from Sandstone staff. ACNW's charter school authorizing mission is to ensure quality academic and environmental literacy outcomes for students in Minnesota through effective charter school authorizing.

ACNW authorized 34 schools during the 2016-17 school year, all which were operational schools and one of which transferred to ACNW during the school year. ACNW approved two new schools during the year which are scheduled to open in the fall of 2018. No ACNW authorized schools closed during the 2016-17 school year; however, one school closed prior to the start of the 2016-17 school year due to financial reasons, most notably the lack of sufficient enrollment, and one had its charter revoked by ACNW and closed prior to the start of the 2017-18 school year.

During SY 2016-2017 the ACNW CSD experienced no staff turnover: David Greenberg continued in the role of full time Director of Charter School Authorizing throughout the year; Rhianon Sargent was in the role of full time Charter School Authorizing Specialist; Mike Schultz continued as full time Performance and Accountability Manager, and Erin Anderson continued in her role as 0.5FTE Environmental Education Evaluator. ACNW was fortunate to host Maggie Kane in the role of Strategic Initiatives Fellow through a fellowship in collaboration with ACNW, the National Association of Charter School Authorizers (NACSA), and the University of Minnesota Humphrey School of Public Affairs. This was a 0.6 FTE position from July 2016 through May 2017. Contracted consultants provided additional support to ensure the CSD's capacity to provide quality oversight to schools. The CSD utilized Epicenter as a tool to enhance compliance and document management of schools. ACNW staff in Sandstone provided administrative, accounting, environmental education, leadership, and governance support.

ACNW continued to invest in professional development for CSD staff through attendance at the NACSA Leadership Conference, participation in the Minnesota Association of Charter School Authorizers, and attendance at other relevant conferences and workshops. In addition, ACNW invested in the development of charter school leaders and board members through the annual ACNW Charter School Leaders Retreat, and for teachers through our 2nd annual Environmental Education Teacher Workshop in the summer of 2016 to support implementation of environmental education strategies at the school level.

For the school year ending June 30, 2017, ACNW had <u>\$539,674 in revenues</u>, <u>\$513,939 in expenditures</u>, and a net <u>surplus of \$25,735</u> from authorizing activities. The vast majority of revenues came from authorizer fees. In addition, some revenues came through a contract with Project in Pride for Living (PPL) to support implementation of PPL's authorizing responsibilities.

ACNW will continue to invest in authorizing activities for SY 2017-2018. The CSD began the year fully staffed, though staffing changes are eminent and new hiring is on the horizon – Mike Schultz is leaving ACNW and moving non to a position at MDE. We also will continue to invest significant time and resources into improving our oversight processes and ensuring resources are focused on our core oversight responsibilities.
