Executive Summary

The Audubon Center of the North Woods (ACNW) is a non-profit organization located in Sandstone whose mission is to instill a connection and commitment to the environment in all communities through experiential learning. ACNW has a Charter School Division (CSD) located in Minneapolis that carries out activities related to charter school authorizing with some support from Sandstone staff. ACNW's charter school authorizing mission is to ensure quality academic and environmental literacy outcomes for students in Minnesota through effective charter school authorizing.

ACNW authorized 36 schools during the 2018-19 school year. Two of these schools were pre-operational and 34 were operational. One of the pre-operational schools opened in the fall of 2019 and one delayed opening to the fall of 2020. ACNW did not approve any transfer schools, new schools, or agree to mutual nonrenewal with any current schools. No ACNW authorized schools closed during the 2018-19 school year; however, one school merged with another charter school (not authorized by ACNW) at the end of 2018-19, becoming one school effective July 1, 2019.

During SY 2018-19 the ACNW CSD experienced some staffing changes: David Greenberg departed in January 2019 and Erin Anderson, Authorizing Specialist, assumed the role of Director of Charter School Authorizing in May 2019. Nalani McCutcheon joined the team in August 2018 in the role of Authorizing Specialist and was promoted to Associate Director of Charter School Authorizing in June 2019, and Rhianon Sargent, Authorizing Specialist, departed in June 2019. Subsequently, the Division was restructured (from a Director and three Authorizing Specialists) to a Director, Associate Director, Authorizing Specialist, and Data and Communications Coordinator for 2019-20. The CSD had part time program and administrative support from Jolene Palme. Her time totaled approximately 0.25 FTE. Contracted consultants provided additional support to ensure the CSD's capacity to provide quality oversight to schools, and ACNW staff in Sandstone provided administrative, HR, accounting, environmental education, leadership, and governance support totaling approximately 0.33 FTE. The CSD continued to use Epicenter as a tool to enhance compliance and document management of schools.

ACNW continued to invest in professional development for CSD staff through attendance at the NACSA Leadership Conference, participation in the Minnesota Association of Charter School Authorizers, and attendance at other relevant conferences and workshops. In addition, ACNW invested in the development of charter school leaders and board members through the annual ACNW Charter School Leaders Retreat, and for teachers through our fourth annual Environmental Education Teacher Workshop in the summer of 2018 to support implementation of environmental education strategies at the school level.

For the school year ending June 30, 2018, ACNW had \$565,370 in revenues, \$568,426 in expenditures, and a net deficit of \$3,056 from authorizing activities. All revenues came from authorizer fees.

ACNW will continue to invest in authorizing activities for SY 2019-20. The CSD began the year by hiring a Data and Communications Coordinator, Mary Williams, and is currently is the process of hiring an Authorizing Specialist. We also will continue to invest significant time and resources into improving our oversight processes and ensuring resources are focused on our core oversight responsibilities.
